We'll be having our Annual Workparty on Saturday, March 20th. It's led by Erik. You can phone him for details at 212-ROCK or just arrive about 9 a.m. with whatever tools you want to use ~ loppers, ladder, various tools ~ and for sure bring your hat and gloves. On the porch we will have the various planned jobs posted so you can choose whatever suits you. In addition to the usual jobs, we'll be building loose rock dams along the north side of the drive. This will be a great opportunity to get practical knowledge in erosion control. We'll provide morning snacks, our famous lunch, and afternoon snacks too.

Our waterharvesting project of 2009 is now in action! The gutter on the porch roof sends 17% of the total roof-harvest into a barrel. When this one is full, it overflows into a second barrel. When that one is full, the water flows into a hose which goes out into the swale and waters the four trees. Water from the 1st barrel can be accessed any time using a spigot just in front of it. Look this system over and see one way you can harvest water at your place. Folks who took this class have information and materials to share with you. Thanks to the Redington NRCD for the class materials and classes taught by Carmen Miller of the U of A Extension Waterwise Program. Report on CWG activities from July 2009 to January 2010

In June we received notice that SouthWestern Power Group (SWPG) was well into the planning stages of their SunZia Transmission Project and that the Bureau of Land Management (BLM) was the Federal Agency over-seeing the Environmental Impact Statement (EIS). The EIS is required by the National Environmental Policy Act. The BLM engaged the Environmental Planning Group (EPG) to develop the EIS. The applicant, SWPG, is responsible for the payment to EPG for its service.

In early July we sent out notices to residents and landowners alerting them that the SunZia Project intended to route two 500 kilovolt (kV) lines with 130' to 160' towers north and south through the San Pedro River Valley from the Winchester substation to San Manuel then west. Included in the notice was a BLM/EPGgenerated comment form. We asked respondents to let us know their thoughts too. The responses were clearly and strongly in opposition to the siting of transmission lines through the valley. With this confirmation we embarked upon our efforts to support this opposition and to prevent further incursion by such infrastructure. From then until December we went about learning everything we could about the issue and its legal process. We spent most of December and early January preparing for a meeting

with Project, BLM, and EPG representatives. Prior to this evening meeting on January 13th, about 30 people toured Soza Mesa and Hot Springs Canyon. In addition to BLM, EPG and SunZia Project, representatives from The Sierra Club, The Wilderness Society, The Nature Conservancy, The Natural Resource Defense Council, The Center for Desert Archaeology, The Center for Biological Diversity, Redington and Winkelman Natural Resource Conservation Districts, Friends of Aravaipa Region, The Audubon Society, Saguaro-Juniper, the Office of Representative Gabrielle Giffords, Cochise County, media, and many residents of the Middle and Lower San Pedro Valley attended.

The tone of the evening was thoughtful and courteous but the content indicated that we will need to pay very close attention. Three CWG members serve as liaison to the Winkelman and Redington NRCDs which have invoked their right to coordinate with the BLM. We all can anticipate a very active and educational year.


